Terms & Conditions of Agreement

1. Phillyart is intended to be an informational site for the arts community. Although this is a binding agreement of membership on the site, the artist expressly acknowledges that this contract is not intended to be construed as an agreement of representation by Phillyart on the artist's behalf.
2. By signing this agreement, the artist expressly agrees that all membership fees are non-refundable, irrespective of termination of the agreement by either party.
3. Either party may terminate this agreement upon ninety (90) days written notice. Upon such termination, Phillyart.net shall have an additional ninety (90) days from the effective date of termination to return all artist materials and to remove such artist information from the site.
4. Artist agrees to indemnify and hold Phillyart harmless from any and all claims, demands, suits, damages or other losses resulting from: (a) the display or sale of his/her art work; or (b) the use of the artist's digital images or other property by Phillyart for any authorized purpose; or (c) any communication or actions that may arise between the artist and website viewers.
5. Artist expressly grants to Phillyart the right to use the artist's images for promotional purposes such as print materials, displays and email/website marketing.
6. Artist explicitly releases Phillyart from any and all claims which arise out of any business relationship formed between the artist and customers.
7. In the event any claims arise out of customers business dealings with Phillyart, all claims must be brought in the Philadelphia Court of Common Pleas, and will be governed by Pennsylvania law.
